(**TCUE**) is a collective body of primarily African American churches in Travis, Williamson and Bastrop counties. **TCUE** is a 501(c) 3 Texas corporation offering a mutually beneficial business partnership between churches and financial institutions, designed to generate increased revenue for the participating banking partners, and better services and savings for the partner churches, congregations and strategic partners. Texas **C**ongregations **U**nited for **E**mpowerment (**TCUE**), Inc. is an affiliate of the **C**ollective **B**anking **G**roup, Inc.

Currently, **TCUE** represents Christian churches in three Texas counties with congregations of more than 5,000 persons. ## Membership Requirements:

**To be a Member Church of TCUE, the following commitments are required:**

1. Pay an annual membership fee and...
  - Transfer all banking to covenant banks within 30 days of membership
  - Encourage church members to do the same.
2. Pastor to select 1 liaison to handle **TCUE** affairs for your church.
3. Actively seek and bring in **3** member churches during the first year of membership, if at all possible church.
4. To ensure that you or your representative attends at least 50% of the monthly general meetings as they are scheduled
5. Be willing to host at least 2 **TCUE** seminars and/or events at your church (if appropriate).
6. Participate in all annual events, conferences and meetings.
7. Promote Covenant Banks to congregational members through announcements, newsletters, etc.
8. Encourage church members and others to attend and participate in TCUE events and conferences.

## Liaison Roles & Responsibilities

In an effort to formalize any and all agreement(s) between the **TCUE**, Inc. and its Member Churches, the following guidelines outline the commitments and responsibilities to be a liaison for your church.

**To be a Liaison for a Member Church of Texas Congregations United for Empowerment (TCUE), Inc. the following commitments are required:**

The liaison must be appointed by the pastor.

- To ensure that you or your representative be willing to attend at least 75% of the monthly liaison meetings. Monthly liaison meetings are generally 90-minutes in length and are held on the 3rd Tuesday of each month or as otherwise scheduled.
- Actively seek and bring in 3 volunteers at your church to assist the liaison in carrying out their **TCUE** functions.

## Liaison responsibilities include

Responsible for responding to **TCUE** information request.

- Responsible for an orderly and timely plan for dissemination of **TCUE** information to church members.
- Coordinate, plan and host at least 2 **TCUE** seminars and/or events at your church (if appropriate).
- Coordinate efforts for your church to have representation and/or delegates at annual events, conferences and meetings.
- To ensure that **TCUE** and Covenant Bank information is available and distributed.
- To coordinate special visits and presentations by our Covenant Banks and Strategic Partners.
- As an added benefit, Liaisons and/or their representatives will receive training opportunities that will be beneficial to the churches and them personally, as that training becomes available.
